This on-line workshop, co-organised by ENRICH GLOBAL Health Innovation Thematic Group¹ in collaboration with IC2PerMed² and PROPHET³ projects, is addressed to policy makers, researchers, innovators, support organisations and other parties from any region of the world who are interested in personalised medicine (PM), personalised prevention and international collaboration. The workshop will allow to exchange experiences and debate around the different PM approaches, on how to better support evidence-based research, infrastructure development, coordination between research and policy, and international collaboration in PM, notably in personalised prevention, digital health, medicine data analysis, biobanking and other related topics. The workshop will bring in the perspective of policy makers, researchers and innovators and possibly identify future topics of interest for international partners to be shared with the international PM initiatives, such as ICPerMed⁴ and EP PerMed⁵. Additionally, the workshop aims to integrate interested health specialists into the ENRICH GLOBAL Health Innovation community of 500+ experts from across the globe, striving to stimulate further exchanges and emergence of new initiatives for stronger health-related international collaboration.
